Product description and identification:

The distributors for under-floor heating and water distribution systems, types RO, RZ, RZP, RPN, RPP and 475 / TLHRO, TLHRZ, TLHRZP, TLHRPN, TLHRP, TLH457, R02280xx are used for regulation of heating outputs in under-floor heating and water distribution circuits. Both parts, i.e. the collector and the distributor, are made of brass and are fitted with individual components according to the type and the use. They are made in the designs for connection ranging from 2 to 12 branches (heating circuits). Distributor sets are dismountable and fitted onto metal supports in such a way that the parts form a compound. Holes are provided to allow fixing to firm basis.
